Report topics are Workers' Comp, Safety, Environment, Business Interruption, and Sustainability, with data collected using a custom App. EAA can assist with items identified in the Gap Analysis; in some cases, we identify options that may eliminate certain obligations.

# **Industrial Hygiene Needs**

### **Exposure Sampling**

Also known as industrial hygiene sampling, this is performed because of an OSHA requirement (e.g. Lead, Silica, Beryllium, etc.), employee complaints, or you want to ensure workers are not being overexposed. EAA can furnish the services of our Certified Industrial Hygienist (CIH) to perform the sampling. We use a Laboratory accredited by the American Industrial Hygiene Association, and use Apps to reduce turnaround time and eliminate errors. Reports include a summary for posting, and a notification letter to employees sampled.

## Noise Program Compliance

Noise exposure presents challenges to your business. Lack of compliance can result in penalties from OSHA, as well as future Worker's Compensation liabilities. EAA can help with your Hearing Conservation Program, by both measuring noise exposures, and "noise mapping" your location. Our reports include a summary for posting, notification letters to employees, and recommendations to control noise, if feasible. All data is included in the report, such as calibration, and notes on PPE.

### Ergonomics

When ergonomics is less than optimal, injuries occur - these can be debilitating, and expensive. Besides the cost, often the employee's quality of life is affected - recovery is rarely 100%. EAA can make recommendations on ergonomic improvements, set up an ergonomic program, and train an internal team. Similar to a safety committee, individuals on this team would serve as an internal resource to review both complaints and potential changes for ergonomic concerns.

### Process Ventilation Testing

OSHA requires industrial ventilation tests annually; this includes laboratory hoods. One important thing about ventilation - more is not better. Drawing too much air pulls contaminants towards employees, and wastes energy. EAA offers a two-phase approach to ventilation system compliance. We evaluate the flow to demonstrate that the system is functioning properly. We also provide comments on design discrepancies and possible improvements, which lead to less energy use.
